ILTA '08: CONFERENCE RULES AND REGULATIONS

1. Conference Package: The consultant pass includes one complete copy of the conference materials, an electronic file of conference registrants as of July 15, 2008, participation in the welcome reception on Sunday evening and the exhibit hall reception on Monday evening, and admittance to the keynote address on Monday morning and all educational sessions, unless otherwise indicated in session descriptions published in the conference notebook.

2. Official Service Contractor: GES Exposition Services is the Official Service Contractor for the Conference. Payment for services provided to the Consultant by GES is the responsibility of Consultant. Information on obtaining forms for ordering auxiliary services (Exhibitors' Service Manual) will be forwarded to you 45 days prior to show time from GES Exposition Services.

3. Cancellation by Consultant: Consultants wishing to cancel their registration must inform ILTA of their intent in writing. A 50% refund will be made on cancellations received after July 1, 2008. No refunds will be issued after August 15, 2008.

4. Consultant Badge: Consultants are required to wear the provided Conference badges throughout the conference. The badges are not transferable, and ILTA reserves the right to withdraw the use of the badge used to gain admission to the Conference Center by any person other than the one for whom it was issued.

5. Hospitality Functions: Any vendor held hospitality, function or social event must be pre-approved by ILTA. Social functions must not conflict with any of ILTA events. No client events with more than 20 attendees (golf tournaments, helicopter rides, etc.) may be scheduled during the day.

6. No Smoking Policy: ILTA maintains a no-smoking policy in the educational sessions, the Exhibit Hall and the demonstration rooms. The Gaylord Texan is a No Smoking property, including the entire conference center and guest rooms.

7. Animals: No animals are allowed in the exhibit hall or meeting rooms except for those trained to help disabled owners.

8. Miscellaneous: (1) Consultant posters or other collateral materials may only be placed in locations pre-approved by ILTA. (2) Marketing materials showing Consultant's social events, demos, demo room educational sessions, etc., along with listing ILTA educational sessions where Consultant is speaking must be pre-approved by ILTA to ensure that attendees can distinguish readily between ILTA materials and Consultant materials. (3) Any gifts or prizes valued at more than \$500 must be pre-approved by ILTA. (4) Pre-conference (sent out on July 15) and post-conference attendee lists can only be used for one mailing each.

9. Amendments: Any and all matters and questions not specifically covered by the preceding regulations shall be subject to the decision of ILTA. These Rules & Regulations shall be binding on Consultants equally with the foregoing conditions. Consultants shall be notified in writing of any amendments to these regulations.
